AN ACT to amend the Proceeds of Crime Act No. 6 of 2012.

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives of Grenada, and by the authority of the same as follows–

## PROCEEDS OF CRIME (AMENDMENT) ACT, 2013.

2. In this Act–

Interpretation

"principal Act" means the Proceeds of Crime Act No. 6 of 2012. Amendment of section 40 of the principal Act. **3.** Sub-section (2) of section 40 is hereby amended by deleting the roman numeral "VI" where it appears and substituting therefor roman numeral "IX".

Amendment of Section 58 of the principal Act is hereby amended as principal Act. follows:

- (a) in sub-section (2) by deleting the words "if its amount is not less than ten thousand dollars" where it appears; and
- (b) in sub-paragraph (b) by deleting the word "of" where it appears before the word "criminal" and substituting therefore the words "or benefits from"
- (c) in sub-section (3) by:
  - (i) deleting: the word "and" where it appears after the word "seized";
  - (ii) by inserting the words "or forfeited" after the word "detained" where it appears; and
  - (iii) in sub-paragraph (b) by deleting the word "of" where it appears before the word "criminal" and substituting therefor the words "or benefits from".

Amendment of Section 60 of the principal Act is amended by deleting the figures "63(2)" where it appears and substituting therefor the figure "58(4)".
